

KNOW YOUR RIGHTS

- YOU HAVE THE RIGHT TO REMAIN SILENT
- YOU HAVE THE RIGHT TO REFUSE TO SIGN ANY DOCUMENTS
- YOU ARE LEGALLY ALLOWED TO RECORD
- YOU ARE NOT REQUIRED TO ANSWER ANY QUESTIONS FROM ICE AGENTS

In Public Areas

- No one can enter a private area like your home, employee area in a workplace, etc without permission or a judicial warrant.
- You have the right to demand they show you their warrant.
- You have the right to refuse to pull down your window and leave the car.
- If they try to force the door open, DOCUMENT:
Descriptions of agents & the license plate numbers.

DOs

- DO carry copies of valid documents of your immigration status (if you have any), such as a green card or work permit.
- If you do not have status, DO carry copies of documents that show that you have been living in the US for the past two years

In Private Areas

- Anyone—including ICE agents-- can be present in a public area without permission
- Your presence in a public space by itself does NOT give ICE the authority to stop, question, or arrest you.
- DO NOT RUN! This may be viewed as evading arrest or reason for suspicion
- DO NOT TRY TO HIDE ANYONE.
- DO NOT TRY TO INTERVENE

DON'Ts

- DO NOT CARRY FALSE DOCUMENTS.
- DO NOT LIE. You have the right to tell law enforcement agents you wish to remain silent.
- DO NOT DISCUSS your immigration status with anyone other than your lawyer.

Stay Calm, Record Photos & Videos Horizontally, Stay a Safe Distance Apart, & Narrate your video documenting the following:

- How many agents there are
- If the agents carried weapons and if they used them
- If the agents blocked the exits or if they limited the movement or activities of the employees.
- Any use of force by agents
- How many vehicles there are
- The license plate number of the vehicles
- What directions vehicles went if they left
- The names & DOB of the people detained, a phone number for a loved one
- The names & contact info of the other witnesses
